3. The purposes of and the legal basis for the processing of your personal data

We are processing your personal data for the following purposes:

• The purpose of processing your data is that the manufacturer or the company responsible for the first marketing in Denmark must register the product (food supplement) before the first day of marketing.

- Order no. 1239/2017 on food supplements.
- Article 10 in regulation 2002/46.

4. Categorization of personal data

We are processing the following categories of personal data about you:

• Name, address, contact person, e-mail, and phone number.

5. Recipients or categories of recipients

We publish your personal data on the website of the Danish Veterinary and Food Administration. The purpose of publishing information on registered food supplements is to create transparency for the retailers and the consumers so it can be publically known which food supplements are registered in Denmark.

6. Storage of your personal data

We are currently not able to inform you for how long your personal data will be stored. However, we can inform you that we will base our assessment on whether the purpose of data storage is still relevant, when assessing the storage period.

All data is retained in accordance with the principles in the Danish Public Information Act, as such being accessible in consideration of the public information in the government. Moreover, we follow Rigsrevisionen (the Danish national audit) and the Danish National Archives' recommendations for archives.

7. Your rights

In accordance with the General Data Protection Regulation, you have certain rights regarding our treatment of your personal data. If you wish to use your rights, please contact us.

The right to request access

You have a right to request access to the personal data about you that we are processing as well as other information.

The right to rectification

You have a right to rectification of inaccurate information about you.
